District 100 continues to focus on the Board of Education and District goals of all students being college and career ready by preparing them with 21st century skills; recruit, support, and retain high-quality staff; create collaborative family and community partnerships; provide a caring, safe, and healthy environment that supports development of the whole child; and efficient and effective management of resources. The District and School Improvement plans drive our work with students and our staffing and budgeting this year including goals for 45% of students meeting or exceeding state standards on IAR in ELA and 40% meeting or exceeding state standards on IAR in Math. We also have goals for continually supporting the social-emotional well-being of students, including analyzing Culture and Climate surveys and providing additional staffing for social work and counseling support, specifically in our middle schools. Expansion of dual language staffing and resources is a priority as our program expanded to eighth grade for the 2023-2024 school year.
